4. PFI Lighting Contract and maintenance options
 - a. No action to date, continues – DA, hopes to action before end of May.

5. Salt Bin – Marlborough Hill
 - a. Nothing in PC budgets which are very tight, T&L resolved to endorse the Grounds Committee decision reluctant to approve one as leads to many.

6. Car Works Green Springs/Pankridge Street Lorry, parking on the pavement on Pankridge Street
